## EDITORIAL

#### THE MO IBRAHIM 2012 REPORT ON NIGERIA

The reason for Nigeria's underdevelopment has been blamed on bad leadership. Poor leadership coupled with of indiscipline, acts corruption and misappropriation of public funds has been linked to the continuous backwardness of Nigeria. The nation has not been able to harness the full potentials that abound in the country, even the little resources that the country has been able to source, has been poorly managed. The Mo Ibrahim Index of African Governance 2012 report. indicate that human rights, political freedom, transparency and accountability have deteriorated in Nigeria as the country was ranked 14th out of the 16 countries in West Africa and 43rd out of the 52 countries listed overall.

This report tells it all and the countries leadership needs to rise beyond rhetoric and take the issue of corruption and bad governance seriously. They need to scourge and return the richly endowed country on the path of prosperity.

Furthermore, Oil and Gas being the mainstay of Nigerian economy has been roundly described as the paradox of plenty by many. This paradox has kept millions of citizens in poverty leading to dissatisfaction among the citizenry. About 60% of the over 160 million people still live below poverty line.

Nigeria's Human Development Index (HDI) value for 2011 is 0.45, in the Low Human Development category, positioning the country at 156 out of 187 countries and territories. Nigerian leaders have not been able to deliver services to the nation above personal interests and it is regrettable that the country has rigmarole for too long because of bad leadership. desires Nigeria а purposeful leadership who

purposeful leadership who can transform the country using available resources. Such leaders must be patriotic in their services to the nation with clear ideology and vision.

#### Implement Transparency Laws, Niger Delta States Urged

# ANEEJ HELD ANTI-CORRUPTION RALLY IN LAGOS - DEMAND SPEADY PROSECUTION OF FUEL SUBSIDY CORRUPTION CASES IN NIGERIA

We, members of the undersigned Civil Society Organisations who have been part of the critical mass of Nigeria citizens who were among those in the streets protesting the abrupt removal of subsidy on petroleum products in Nigeria on January 1, 2012 and who also have been following the issue from thence, hereby express concern over the slow pace of prosecution of fuel subsidy corruption cases.





We therefore are making the following demands:

- The federal government should speed up the prosecution of fuel subsidy corruption cases that are currently pending in court where notable oil marketers and their companies are involved.
- Presidential candidates standing for the February 14, 2015 polls should tell Nigerians how they will end fuel subsidy corruption.
- The Nigerian Bar Association, other Civil Society Groups and even individual lawyers should immediately provide Pro Bono Services to the Economic and Financial Crimes Commission (EFCC), to fortify their prosecution team.
